# Terms and Conditions for ReadySetSent - Online Delivery Service

#### 1. Introduction

These Terms and Conditions ("Terms") govern your use of the online delivery service provided by ReadySetSent ("Service"). By using the Service, you agree to be bound by these Terms. If you do not agree with these Terms, please refrain from using the Service.

#### 2. Definitions

"ReadySetSent" refers to the online platform and service for the reverse auction delivery system.

#### 4. Use of the Service

- 4.1 Account Creation: To use the Service, you may be required to create an account. You are responsible for maintaining the confidentiality of your account information and for any activities that occur under your account.
- 4.2 Driver Eligibility: If you wish to participate as a Driver, you must ensure that you are self-insured with a provider of your choice, in accordance with applicable laws and regulations. You are responsible for maintaining valid and up-to-date insurance coverage during your participation in the Service.

## 5. Bidding and Auctions

- 5.1 Reverse Auction System: ReadySetSent operates as a reverse auction platform, where Drivers can bid on available delivery requests from Users. The winning Driver is based on their bid being the lowest.
- 5.2 Payment: The fees and payment terms for the delivery services will be determined by the winning Driver's bid and agreed upon by the User.

## 6. Liability and Insurance

- 6.1 Driver Liability: Drivers are solely responsible for their actions and deliveries, including any liability or damages that may occur during the delivery process. ReadySetSent does not assume any liability for the actions of Drivers.
- 6.2 Insurance Requirement: Drivers must maintain self-insurance from a Provider of their choice, as required by applicable laws and regulations. ReadySetSent is not responsible for verifying or enforcing a Driver's insurance coverage.

### 7. Disputes

In the event of a dispute between a User and a Driver, it is the responsibility of the parties involved to resolve the matter. ReadySetSent is not liable for any disputes or issues arising from the use of the Service.
